- **3.** Board & Administrator for Board Members Monthly Publication December 2020 Reflection I have provided a brief reflection on a few of the articles from the December publication. I hope you have had an opportunity to read and reflect.
 - <u>Don't let split votes cause division on your board</u> The article acknowledges the challenges some school boards face with issues and decisions that may be somewhat controversial throughout the community resulting in split board votes. With "emotional" or strong opinioned issues, the author provides suggestions for a board chair and board to consider including:
 - If there is time, discuss the issue(s) at one meeting and then table the issue until the next meeting for action to provide board members to reflect on their position.
 - ➤ Generate solutions by having individual board members submit potential solutions to the superintendent to chart and prioritize.
 - Send issue to committee for more discussion, research and recommendation.

- Hold virtual stakeholder meetings to foster public trust The article encourages a board to
 hold "virtual stakeholder meetings" to foster public trust; especially during times like the
 pandemic that has resulted in unprecedented challenges and decisions for school districts.
 Three steps to make the virtual meetings successful include:
 - 1. Identify and invite leaders (community, business, parent, etc.) to meeting
 - 2. Host meeting by greeting and facilitating
 - 3. Actively participate in meeting.
- <u>Use self-evaluation to assess our performance as a board member</u> The article encourages school boards to conduct a self-evaluation and offers a brief board member self-evaluation that individual board members may use to reflect on their board member performance.
- **4. January 25 Budget Work Session Planned** The Board is scheduled to meet on January 25 beginning at 5:30 pm in the Secondary School Media Center. The purpose of the work session will be to begin development of the 2021-2022 budget. Administration is in the process of developing a preliminary budget based on initial revenue and expenditure assumptions.
