- **3.** Board & Administrator for Board Members Monthly Publication January 2019 Reflection I have provided a brief reflection on a few of the articles from the January publication. I hope you have had an opportunity to read and reflect.
 - What should you expect of your superintendent The article provides guidance about board and administrator roles and responsibilities from both the perspectives of the board members and of the superintendent.

The superintendent should expect from the board to:

- ✓ Provide counsel, advice, expertise and insight into local community
- ✓ Delegate responsibility for management to superintendent
- ✓ Refrain from managing administrative functions including personnel
- ✓ Understand that staff report to the superintendent
- ✓ Communicate openly and honestly with superintendent
- ✓ Support the superintendent
- ✓ Hold superintendent accountable for district's performance
- ✓ Provide annual evaluation of superintendent's performance
- ✓ Plan strategically for district's future
- ✓ Arrange educational opportunities for board

The board should expect from the superintendent to:

- ✓ Communicate promptly, openly, and honestly
- ✓ Act as board's professional advisor
- ✓ Implement board policies
- ✓ Serve as district's CEO
- ✓ Recommend appropriate policies for board consideration
- ✓ Present professional recommendations on all problems and issues
- ✓ Develop budget for board consideration
- ✓ Keep board informed of district's financial status
- ✓ Recruit competent personnel; develop and supervise them
- ✓ Assist the board in developing effective community information programs
- ✓ Provide board with professional judgement about district needs
- ✓ Participate in strategic planning
- ✓ Provide board with annual self-appraisal
- <u>Balance what's best for all with your personal interests</u> The article reminds board members of their role in supporting staff with a focus on student learning.
- Get more out of your superintendent's evaluation form The article suggests providing individual board members the opportunity to offer written comments as part of the superintendent's evaluation that allows for specific feedback. The author also suggests for boards to consider including a section at the end of the evaluation instrument that allows for board responses to open-ended questions. I would add that while I value individual comments and that we allow for that opportunity as part of our process, the final evaluation reflects only the full board's assessment.
- <u>Meetings</u> The article provides meeting "norms" to help the board's meetings remain on task and focused including:
 - ✓ Meetings follow a system of parliamentary procedure
 - ✓ Stick to the agenda
 - ✓ Start on time and end on time
 - ✓ Board members arrive on time

- ✓ Keep length of meetings two hours or less
- ✓ Board members come prepared
- ✓ Board members participate in discussion
- ✓ Minimize board member absences
- ✓ Room/space is comfortable
- ✓ Committees only meet when necessary
- ✓ Discussions cordial and all members involved
- ✓ Agendas include positive items
- ✓ Controversial items addressed and solutions acceptable to all board members developed
- ✓ Minimize need for closed sessions
- ✓ Meetings focused on policy, planning and evaluation
- **4. Design and Build Update** The bid opening was held on Thursday, February 13 at 3:30 pm. As of this time writing my report, I do not have further information to share regarding results. A special Board meeting is tentatively scheduled for Wednesday, February 26, beginning at 5:30 pm, for the purpose of considering approval of bid recommendations.

The construction of the shop addition is planned to begin in April or May contingent on weather and other scheduling considerations. The majority of the project is planned to be completed over the summer of 2020 with the shop addition at the Secondary School being completed by late 2020.

We continue to work on a facility usage plan for summer 2020 that will minimize disruption to summer programming.
