COVID-19: Three COVID-19 education trends set to persist post-pandemic How to keep schools open safely

- 2. COVID-19 County Case Rate and Learning Models We continue to monitor closely the county case rates as well as our quarantine and positive cases in the school district. Unless we experience positive cases or a high number of quarantines, I anticipate continuing with *Hybrid Learning* for both buildings for the next several weeks. Based on the Board's discussion at the last School Board meeting, the Board will be convened when it is believed there is data to support a potential move to a different model. Board members can give me a call with questions or they can also contact Board Chair Rick Schultz. A request for the Board to convene to review the case rate and current learning models should be forwarded to Mr. Schultz.
- **3.** World's Best Work Force (WBWF) Plan Review Public Meeting Change MDE provided more clarity this week regarding the WBWF review process. At this time, we plan to present a review of our progress with the 2019-2020 WBWF plan at the November 16, 2020, School Board meeting. We may also present a draft of the 2020-2021 plan for Board consideration. MDE is modifying the report template to acknowledge the absence of MCA student assessment data from the spring of 2020.
- 4. MSHSL Engagement Session I listened in on today's session but did not feel that I learned any new or helpful information to better understand the rationale for how the MSHSL determined the COVID-19 additional fee structure. I don't believe we are going to get a response to the specific question at this point.
- 5. School Learning Model Look-up A question was asked at Monday's Board meeting if I knew the different learning models of area school districts? One can go to the MDE website at Enter the Safe Learning Model Look-Up system to look up the current learning model for each school district, school building, grade level, etc. Simply enter the school district you are seeking.
- 6. Building and Grounds Committee Meeting to Meet After visiting with Rick Schultz, the next Building and Grounds Committee Meeting is tentatively planned for Tuesday, January 19, 2021, beginning at 5:30 pm prior to the start of the regular School Board meeting. Agenda items may include discussion about potential land sale, construction project follow-up, and examining the Board's goal of developing a long-term facility plan.
- 7. Election Night Gathering Please let Rick Schultz or me know if there is interest in providing an opportunity for Board members to convene Tuesday evening on November 3, to monitor election results. We would publish that there would possibly be a quorum of the Board but now business would be conducted. We are not confident that results will be made available by 10:00 pm.
