We continue to live-stream the Board meeting via YouTube. Board members and essential staff will continue using *Google Meet* to access and participate in the meeting.

- ### 3. School Learning Model Update –
- On Wednesday, December 16, Governor Walz directed the Minnesota Department of Education (MDE) to provide new guidance that prioritizes putting elementary students back into the classroom. Per the updated [Safe Learning Plan for the 2020-21 School Year](#) as 12-16-2020, elementary schools may “*reduce the use of county data as a singular determining point when considering their learning models, and mitigation strategies are increased to help get students back in classrooms while keeping students, families, educators and staff safe.*”

The *Safe Learning Plan* will allow an elementary school to choose to operate an *in-person learning* model beginning January 18, 2021, as long as they are able to implement additional mitigation strategies that you will find in the *Safe Learning Plan*.

Staff leaders continue to develop transition plans to prepare the Elementary School to move to *in-person learning* and to determine if we will be able to implement the required mitigation strategies. We continue to seek clarification as to start dates for *in-person learning* for Elementary and *hybrid learning* for Secondary and how the Board's directive from December 15 to move both schools to *hybrid learning* no earlier than January 11 might be impacted.

The guidance for determining when the Secondary School may move to a less restrictive learning model has not changed. At this time, we believe the Secondary School will resume *hybrid learning* on January 11 as directed by the Board. The additional mitigation strategies also have to be in place for the Secondary School in order to move to *hybrid learning*; however, a 2-week “rolling start” will not be required of the Secondary School as we had consulted with our Regional Support Team on December 15 prior to the Governor’s announcement.

Regardless of what learning model we are in, we will still monitor positive cases and quarantines within both school buildings. The need to move a school to *distance learning* will continue to be a possibility due to either virus spread within the schools and/or communities, along with our ability to staff our schools.

An update will be provided to the Board at Monday’s meeting.

4. **Winter Activity Start Date Update** – At this time, we are planning to begin winter activities on Monday, January 4, if all health and safety procedures are in place.
5. **2021-2022 Budget Work Session Planned** – A Board Budget Work Session will be held on Monday, January 25, 2021, at 5:30 pm in the Secondary School Media Center, to begin addressing actions needed to occur in order to achieve the Board’s finance goal of that *by June 30, 2020, adopt a planned budget for 2021-2022 that achieves the Board’s fund balance target range while balancing the amount of revenue with planned expenditures. In the event of an unsuccessful referendum vote, the Board will need to be prepared to conduct a budget reduction process in advance of adopting the 2021-2022 budget.* The Finance Committee may be asked to meet prior to the work session.
6. **2021 MSBA Leadership Conference** – The 2021 MSBA Leadership Conference will be held virtually this year on three different Thursday mornings. As it is free, Sue Kulseth went ahead and registered each Board member. See the communication below from MSBA

You also shared that you are saving the nights and weekends for your family and away from technology. The preferred date and time for attending the conference virtually is Thursday mornings.

- **Gore** is in his sixth year as Division Director for Board Development Services with the Texas Association of School Boards and is a nationally recognized researcher on school governance.
