2. Learning Model Update – The majority of our Grade 6 students started this week attending school four days a week. Mr. Bunn has announced that Grade 12 students who had responded 'yes' to a survey regarding interest in attending school "in person" four days a week under hybrid safety health standards will be able to begin Monday, February 1. Once the staff has had the opportunity to confirm the number of students attending, consideration for increasing the number of interested students will be examined based on available capacity.

Administration held a Regional Support Team (RST) consultation this week regarding guidance and criteria to be considered when developing a potential plan to maximize the number of our Grade 7 and Grade 8 students to attend in person more days in a week than the current two. The RST reminded us that the Safe Learning Plan guidelines have not changed for our older students. If we are unable to provide the recommended 6 feet of distancing, then we would not be following the recommendations of public health officials unless we can put in mitigation strategies similar to what we have done for grades K-6. Administration will continue to examine strategies and a plan to submit to the RST for consideration in providing more in person opportunities for our grades 7 and 8 students.

- 3. Vaccine Update While we have had great success in the past two weeks in getting appointments for those employees who expressed interest in receiving the vaccine, I am concerned about the low percentage of our employees wanting the vaccine. There is some speculation that a future guideline/criteria/metric for determining moving secondary level students to in-person learning might include the number/percentage of staff who have received the vaccine. We currently are at about 50% for the district. I do not have the breakdown per school building at this time. We did survey employees a second time to offer another opportunity to be put on the vaccine list and will know the results later today.
- 4. Secondary School "Panther Den" Principal Bunn provides below a summary of an "after-school homework help" program named Panther Den that is in the process of beginning as early as next week.
  - After School Homework Help is otherwise known as "Panther Den" (Doing Everything Necessary)
  - Students will be offered the opportunity to come in after school virtually or in-person on Tuesdays and Thursdays. Those days are chosen to allow hybrid students that are home to access assistance via Google Meet.
  - Two teachers will facilitate the program.
  - The program will run from 3:30-5:00 for the MS and 3:15-4:45 for the HS in the lower commons, starting February 1.
  - Compensation will be based on the teacher contract under Teacher's Compensation-School Year applied to Targeted Services. Total cost is estimated at about \$4,800 and will be funded through COVID-19 relief funding.
