2. Building and Grounds Committee Meeting Notes – The Building and Grounds Committee met on Tuesday, June 1. The meeting agenda and recommended action included:

- Examining Secondary School / District Office electronic sign proposals and determining recommendation to forward to School Board – The Committee is planning to recommend to the Board at the June 21 School Board meeting to move forward with M & M Signs with the replacement of the Secondary School electronic sign at a cost anticipated to be between \$25,000-\$30,000. The other quote from AIM Electronics for what the Committee believed to be a comparable sign installation is about \$40,000.
- Reviewing a potential property purchase and determining recommendation to forward to School Board – The Committee examined a potential purchase of property close to the New Richland bus garage. Further research was going to be conducted before bringing the matter to the Board at a future Board meeting.
