Facilities Bond Sale Update

As you may have read in the July 25 Star Eagle edition, the School Board approved moving forward with the \$9.1 million bond sale at the July 15, 2019, School Board meeting. The School District is pleased with the favorable rate of 2.6% compared to the higher rate of about 4% shared with taxpayers prior to the April 9 special election. The Board approved partnering with PFM Asset Management LLC for the investment management of the bond proceeds.

Ag2School Credit Update (By Karla Christopherson, Business Manager)

Leading up to the April 9 special election, the School District had shared information about the Ag2School Tax Credit first enacted into law during the 2017 legislative session that established a 40% credit on taxes paid on all current and future capital referendums for ag land owners. In the 2019 legislative session, lawmakers enacted a law to increase the credit amount over a four-year period beginning with 50% in 2020, 55% in 2021, 60% in 2022, and 70% in 2023.

This increased credit means higher property tax relief for ag land owners than previously thought at the passage of the April school bond referendum. According to Michael Hart, with Northland Public Finance, an agriculture property in the NRHEG school district valued at \$500,000, will see a total tax increase after the 40% Ag2School credit of \$54.75, at 50% the increase is \$45.63 and by the time this credit reaches 70%, the increase will drop to \$27.38.

"It is estimated the Ag2School credit increase will deliver up to \$10 million in property tax relief for farmers in fiscal years 2020-2021 and \$44 million in fiscal years 2022-2023. In addition to MCGA, an increase in the Ag2School credit was a priority for several agricultural groups in addition to the Minnesota Rural Education Association." (Minnesota Corn Growers Association, May 28, 2019 website posting)

The Ag2School Tax Credit (Minn. Stat. 273.1387), does not indicate an end date for this credit and any changes to the law would require legislative action. "Eligible properties will see this credit presented in the top right corner of the proposed property tax statement, labeled 'SBBAC'. The credit is not shown on the final property tax statements but a land owner can call their county Auditor/Treasurer's office after the final statements are mailed out for the exact amount of the credit" according to Tammy Spooner, Waseca County Auditor-Treasurer.

Construction Update

The School District has reached an agreement with Knutson Construction to provide Construction Manager services for the remodel and building project. ISG architects and engineers are in the process of working with District staff to develop preliminary designs of impacted classroom and other building areas. An estimated timeline calls for finalized plans to go out to bid late 2019 or early 2020 with construction beginning late spring 2020. The majority of the project is planned to be completed over the summer of 2020 with the shop addition at the Secondary School being completed by late 2020. Updates are planned to be posted to the District's website.
