#### Workforce

<u>Resignations/Retirements</u> – The Board approved the following resignation/retirement notices. Thank you to Ashley, Renee, Kari, and Terri for their service!

- Ashley Tolzman Secondary School Paraprofessional. Effective April 8.
- Renee Moravec—Speech & Language Pathologist. Effective at the end of the 2019-2020 school year.
- Kari Olson Secondary School Teacher (6<sup>th</sup> Grade). Effective at the end of the 2019-2020 school year.
- Terri Engel Curriculum & Instruction Coordinator. Effective at the end of the 2019-2020 school year.

<u>Preliminary 2020-2021 Staffing Plan</u> – The preliminary staffing plan for 2020-2021 was presented. The Board will be asked to consider approval at the May Board meeting. A few highlights to note:

- <u>Projected Enrollment</u> We are projecting little change in District-wide enrollment compared to the actual enrollment as of March 31, 2020.
- <u>Elementary Classroom sections</u> -- No change in the overall number of Bridges/Kindergarten through Grade 5 classroom sections (19)
- Reduction in DAPE A 0.2 FTE reduction in Developmental Adapted Physical Education (DAPE) is projected at the Elementary due to anticipated student needs.
- Secondary staffing -- Secondary staffing shows a 0.6 FTE reduction in overload assignments.
- Secondary Overloads 0.4 FTE total in overloads are projected in FACS and Math
- <u>Secondary canceled courses</u> A total of 9 courses are planned to be canceled due to low enrollment or due to teaching FTE capacity. The two FACS courses where 27 students selected each must be canceled as our FACS instructor already has an overload for both semesters.
- Curriculum & Instruction (C&I) Coordinator position The 1.0 FTE C & I Coordinator position was reduced to 0.5 FTE for 2019-2020. The 2020-2021 preliminary plan includes reducing the position from 0.5 FTE to 0.2 FTE. The recommendation is made acknowledging the impact it will have on staff support. This is the only position being recommended for reduction that is not enrollment driven.
- <u>Staffing Contingency</u> In the past, the Staffing Plan has not included "contingency staffing," even though I have suggested each year it would be fiscally wise to include contingency funds targeted for staffing changes as it is likely there will be a need to add staffing as we move closer to the start of a school year. In the past four years, we have added staff three of those four years between the time the Board approved the Staffing Plan in May and the start of the school year. I have included 0.6 FTE in contingency staffing in this plan.
- <u>Budget Impact</u> The total planned staffing adjustments result in an estimated cost savings of about \$20,000.

<u>Interquest Detection Canines of Minnesota Agreement</u>: The Board approved renewing our agreement with Interquest Detection Canines of Minnesota. The agreement has not changed from last year. Each visit will be \$300/half day or \$450/full day; mileage is a flat rate of \$30 per visit.

<u>Preliminary 2020-2021 Budget</u>: Karla Christopherson and I presented the preliminary 2020-2021 budget currently being developed. The Board will be asked to consider adopting the 2020-2021 budget at the May Board meeting. At this time, the budget includes using up to \$200,000 from the District's fund balance with an additional \$130,000 in reductions. It is likely these numbers will change as we move forward.

<u>Audit Bid</u>: The Board approved the recommendation to enter into a three-year agreement with Abdo, Eick & Meyers.
