  - 1) Student Learning Interventions: Principals Anderson and Bunn presented an update on interventions in place and/or are being planned and researched for researched for potential implementation to assist students in response to increasing learning gaps due to hybrid and distance learning.
  - 2) Secondary In-Person Transition Process: An updated was given on the process to be followed in determining when consideration may be given to transition some or all Secondary School grade levels to in-person learning. Mr. Bunn presented on a proposal to move Grade 6 to in-person learning at a date TBD contingent upon Regional Support Team review. Plans to move Grade 12 to in-person learning under hybrid learning mitigation strategies was presented.
