- 3) Purchase of Service Agreement for Mental Health Services with South Central Human Relations Center, Inc. (Vision, Audio, O&M): Agreement total is \$4,709.67 for the 2023-2024 school year with Audiology to be determined.
- **4) Southern Plains Education Cooperative #0915 with NRHEG for Staff Sharing**: We were receiving our physical health disability services from Southern Plains last year also. Previous to SP we were with MVED. We have always had a contract with someone for this required position.
- 5) Certified Occupational Therapist Assistant (COTA) Agreement with Janesville-Waldorf-Pemberton Public Schools (JWP): The Board will be asked to renew the agreement with the JWP Public Schools for instruction staff sharing of the COTA for the 2023-2024 school year. The COTA's time will be split with 50% in our District and 50% in the JWP District. We will continue to pay the entire employment costs to include salary, benefits, travel, and other related program costs. The agreement calls for the JWP School District to reimburse the NRHEG School District an estimated amount of \$24,168.14. Subject to final salary and fringe contract settlements.

6) Certified Occupational Therapist Assistant (COTA) Agreement with Naomi Elmhorst: I am recommending the board approve the COTA contract for Naomi Elmhorst for the 2023-2024 school year in the amount of \$36,250 which reflects a 4.25 rate increase from the prior year's amount of \$34,741. We share Ms. Elmhorst's service with JWP 50%; NRHEG at 50%.
