SCHOOL BOARDS THAT GOVERN DISTRICTS AND CHARTER SCHOOLS ARE REQUIRED TO DEVELOP COMPREHENSIVE, LONG-TERM STRATEGIC PLANS THAT ADDRESS THE FOLLOWING TO THE WBWF GOALS:



The number of students with failing grades will be reduced by 25%.

STATE VS. NRHEG GAP REDUCTION IN READING

1. F&R Students vs. Non F&R Students

District learning gap increased by 1.2 percentage points.

State reduced the learning gap by .5 of a percentage point.

2. SPED Students vs. Non SPED Students

District reduced the learning gap by 6.5 percentage points.

State Gap reduced the searning gap by 1.4%.

STATE VS. NRHEG GAP REDUCTION IN MATH

1. F&R Students vs. Non F&R Students

District reduced the Gap by .6 percentage points.

State learning gap remained the same.

2. SPED Students vs. Non SPED Students

District reduced the learning gap by 11.3 percentage points.

State reduced the learning gap by .7 percentage points.

GOAL #4 ALL STUDENTS ARE READY FOR CAREERS AND COLLEGE

College and Career Readiness: By 2024, 100% of 12th grade students completing the Minnesota Career Information System activities, (including a Career Cluster Survey, the Ideas Interest Assessment, online portfolios and career planning) will increase from 0% in 2019 to 100% in 2024.

We are on track to meet this goal in 2023-2024.



GOAL #5 ALL STUDENTS GRADUATE FROM HIGH SCHOOL

By June 2023 NRHEG's 4 year graduation rate will meet or exceed the Minnesota state average.
