- **2. 3-20-17 School Board Meeting** A few items to bring attention to . . .
 - a. <u>Teaching and Learning Feature</u> Teri Engel and Sue Nelson will present information on the Elementary School's Minnesota Reading Corps Program.

b. Workforce Items

- **Hiring Recommendations and Retirement Notice** We are excited about having Family and Consumer Science teacher Riley Holmes join us next year as she replaces retiring LaDona Flowers!
- **Job Share Requests for 2017-2018:** The Board will be asked to approve the paraprofessional job share teams for 2017-2018 of Karen Nafe/Donna Olson at the Secondary School, and Judith Tweeten/Lori Tomsche also at the Secondary School.

c. Student Achievement Items

• Cancelled School Days and Make-up Plans – The Board will be asked to determine if the cancelled school days on February 24 (inclement weather) and/or March 15 (Girls Basketball State Tournament) are to be reschedule for students. I have listed four options below for the Board's consideration. I share more information on each option in my Agenda Letter to the Board included in the Board packet.

Option A: Extend the student day seven (7) minutes in response to February 24 and not reschedule the March 15 cancelled day.

Option B: Reschedule the February 24 cancelled day to June 7, and not reschedule the March 15 cancelled day

Option C: Reschedule the February 24 cancelled day to June 7, and reschedule the March 15 cancelled day to June 8

Option D: Extend the student day 14 minutes in response to both cancelled days on February 24 and March 15

- Flexible Learning Day -- Mr. Bunn and Mr. Anderson will present information supporting an administrative recommendation for the Board to consider approving a plan to schedule up to three (3) Flexible Learning Days for the 2017-2018 school year to be used in the event students and staff are unable to report to their building due to inclement weather or some other unplanned event.
- 2017-2018 School Year Calendar -- The Board will be asked to consider approval of the 2017-2018 school year calendar as recommended. I have relied again on the involvement of a staff committee to advise me on the development of the calendar. As part of my presentation, I will share highlights of the calendar including a change in parent-teacher conferences at the Elementary School, the scheduling of teacher professional development days within the school year, and plans for up to five (5) cancelled school days for students.

d. Finance Items

- **Budget Development Calendar** Karla Christopherson and I will present a calendar that identifies the different events throughout the year required in developing the annual budget of the school district. After presenting to the Finance Committee, it was suggested not to have the Board approve the calendar; rather, have administration share as information and provide the Board to ask any questions.
- Fund Balance Policy (714) Revision The Board will be asked to approve the first reading of the Fund Balance Policy to included revisions. The Finance Committee reviewed the revisions and approved forwarding to the Board for a first reading.
- Uniform Grant Guidance Policy (721) adoption The Board will also be asked to approve the first reading of the Uniform Grant Guidance Policy. School districts are required to have policies which establish uniform administrative requirements, cost principles, and audit requirements for federal awards to school districts. The Finance Committee reviewed the policy draft and approved forwarding to the Board for a first reading.
- **2. Policy Committee** The Policy Committee plans to meet on Monday, March 20 beginning at 5:30 pm in advance of the regular School Board meeting. The tentative agenda will include review of policy revisions for Consent Agenda (203.6) and Public Comment (206).
- **3. Paraprofessional Negotiations** The first negotiations meeting is scheduled for Tuesday, March 21, beginning at 5:30 pm in the Secondary School Board Room.
- **4. Teacher Negotiations** The first negotiations meeting is scheduled for Tuesday, April 4, beginning at 5:30 pm in the Secondary School Media Center.
- **5.** Community Night Out -- The annual Community Night Out Live and Silent Auction sponsored by the NRHEG Parent Teacher Organization is scheduled for Saturday, April 1, 2017, to be held at Wedgewood Cove in Albert Lea. The Community Night Out event fundraises for the purpose of contributing to the life of the School District in various ways with a primary focus on students. Participation at the event as well as donations are appreciated.
- 6. Facility Assessment Update ISG plans to be in the district on March 30 & 31. I have had the question when will Board members have the opportunity to meet with ISG? The response from ISG has been that typically the Board is the final group to receive the assessment information after ISG has conducted its assessment of the physical and mechanical condition of the facilities as well as staff input pertaining to programming. The Board receives the information and then has the opportunity to share thoughts with ISG. Following Board input and discussion, the Board will then determine next step which may involved putting together a community task force to study the findings and come back to the Board with a recommendation on how to move forward. Let me know if you have questions.
