2. Snow Day Relief Bill Update - The "snow day relief bill" was passed in the Senate and House yesterday (Thursday). As I write this Friday afternoon, I have not heard if the Governor has signed it or not?

I have already received the same question from two different individuals whether or not the Board is going to modify again the 2018-2019 calendar as a result of the "bill?" My response has been that I have had no indication that there would be a change. One of the individuals thought that the "bill" was a mandate and that districts had to forgive or count all cancelled days and then also compensate staff for the cancelled day. I responded that 'no,' the bill is not a mandate. The decision is left to a school district. If a district makes the decision to access the language in the bill, then the district must follow all of the provisions of the bill.

A reminder that we cancelled school on January 30, 31, and February 20 \& 25 for students and staff. School buildings were also closed and designated as Flexible Learning Days on January 22, 28, 29 and February 7 \& 12. On the Flexible Learning Days, the majority of our hourly employees did not work. As reflected in the Paraprofessional Master Agreement, paraprofessionals have the option of "making-up" for those five days as scheduled by the building principal. The first make-up day for paraprofessionals was March 4. Other days are being planned with the principals; however, there are no make-up options for other hourly employees i.e. food service, some clerical, and drivers.

The four cancelled days identified above have been rescheduled as student instruction days on March 25, April 18, and June 3 \& 4. The two teacher work days originally planned for March 25 and April 18 which were non-student days originally, have also been rescheduled. We also will have a full student instruction day on March 6 which was originally scheduled as a 2 -hour late start.

So with the passage of the "bill," districts may count cancelled days (non-Flexible Learning Days) as student instructional days for purposes of calculating the number of hours and days in the school year. As I shared at the March 6 Special Board meeting, the District already exceeded the minimum number of required hours by almost two days by rescheduling the four days; however, the rescheduling of days was focused on recapturing as much lost instructional time believed to be appropriate.

If the Board wishes to revisit this issue and consider reducing the number of rescheduled days by accessing the language of this bill, then the following would apply.

- The board of a school district or charter school that canceled school on one or more days during the 2018-2019 school year due to health and safety concerns may count those days as instructional days for purposes of calculating the number of hours and days in the school year. This especially applies to school districts who fall under the minimum 165 days of instruction and required hours.
- If a school district would not have met the required minimum number of days and hours of instruction for students, it must report to the commissioner of education the number of days and hours that the district counted to meet the required days and hours of instruction. A district is also encouraged to adopt an e-learning plan.
- If a school board resolves to count a day that school was canceled as an instructional day, the school district must compensate employees and contract employers by paying them or allowing them to work another day the school designates.
- The minimum number of days of teacher service that a probationary teacher must complete equals the difference between 120 days and the number of scheduled instructional days that were canceled due to health and safety concerns and that the school board resolved to count as days of instruction.

In the end, this bill may have less impact on us at this point since the Board could cancel the rescheduled days on June 3 and 4, and still meet the minimum number of hours required by the state. Since the District would be above the state required hours, it may not have to access this language and could address the issue of employee compensation as it believes to be appropriate and also meet the requirements of any negotiated master agreement.

Let me know if you have any questions; otherwise, I will leave it to the Board if it is interested in revisiting this issue given the passage of the recent bill.
3. April 9 Special Election Update - We should expect the reminder postcard in households by Wednesday of next week reminding eligible voters to vote. We are planning for a public gathering at the Secondary School around 7:30 pm on the evening of April 9 to learn of the results.
