- 2. Board & Administrator for Board Members Monthly Publication November 2018 Reflection I have provided a brief reflection on a few of the articles from the November publication. I hope you have had an opportunity to read and reflect.
 - Vision, mission, and theory of action should be aligned The author shares the importance of vision and mission; why you exist as a school district and what is your purpose. The author suggests that in a highly effective and performing school district, the district's vision and mission is aligned with the personal visions and missions throughout the organization. Creating a "theory of action" by aligning vision and mission throughout the district is critical to the success of the district.
 - Expensive judgment against district, members of the board avoidable The article brings attention to the importance for the board to define the board's role in specific areas including hiring. In the article, consultant Rick Maloney suggests boards and board members should not be involved in the selection of employees, but rather, ensure the 'process' is legal and

ethical. He suggests board members level of participation in the selection process should be limited to "review and approval," but not be involved at the administrative level of interviewing and selecting.

- <u>Board represent the community connection</u> The article reminds us of a boards critical role in connecting the school district with the larger community; in our case, four communities! The article offers some reminders including:
 - 1. All board members realize the purpose of the district
 - 2. All board members are familiar with the history of the district and know its mission and vision
 - 3. Board members know the difference between the roles of management (superintendent) and governance (board)
 - 4. We recognize the board is the vital link to the community the district serves
 - 5. All members realize their commitment of time, effort, and leadership on the board is key to the district's success
- 3. Facility Planning Update If the Board approves the facility bond referendum resolution and MDE's Review and Comment document at the December 17 School Board meeting, then an important next step will be for the Board to hold a work session in January to review communication plans important to educating our communities about the project needs identified as part of the election question. Our consultant, ISG, is already working on a communication framework. Internally, I am working with principals to put in place systems and opportunities for staff to understand the project plans. It is important for the Board to continue leading the conversation throughout our communities about our facility and programming needs. I will work with the Board chair to identify potential dates to hold a work session sometime in January.
- 4. 2019 MSBA Leadership Conference We believe everyone is set for the conference. I will be joining newly elected members Rich Mueller and Luke Routh on Wednesday, January 16, as they will be attending the Phase II training facilitated by MSBA. The training begins at 8:45 am and continues until 4:00 pm. I will be available later in the afternoon and evening on Wednesday to assist board members as you check in at the hotel. You should have a room reservation in your name when you arrive at the hotel. Mr. Mueller and Mr. Routh are planning to attend additional "Early Bird" sessions Wednesday evening. There may be interest for Board members to gather informally Wednesday evening and even discuss plans for Thursday including sessions to attend. We traditionally have met for breakfast Thursday morning around 7 am which may also provide an opportunity to review plans for the day. In the past, we have sat together for the opening session Thursday morning. Following the opening session, members have divided up and attended sessions according to personal interest and/or perhaps a general interest expressed by the Board.

Lunch plans on Thursday do not include the MSBA recognition lunch this year. However, meeting for lunch can be another opportunity for members to come together and share what they have already learned as well as discuss plans for the afternoon. As the afternoon comes to a close, it has been our tradition to enjoy a meal together Thursday evening.

Friday morning typically starts once again with breakfast around 7:00 am and then includes additional sessions as well as the closing session where we once again have sat together. The conference ends by noon on Friday. You may want to consider checking out of your room early Friday morning before heading to the Convention Center.

A reminder that when the Board members attend the conference, there will often be times a "quorum" of the Board will be present. While the conference is a wonderful opportunity to learn together which at times involves discussing school board best practices, the Board will not conduct

- any school district business. Please let me know how I can assist you as you navigate the many opportunities at the conference. I look forward to spending quality learning time with you.
- **5. District Website Update** I hope you have had an opportunity to experiment with the updated website. Sue Kulseth and I plan to share some highlights at the December 17 Board meeting.
- **6. January 7, 2019 Organizational Meeting** The School Board will also be holding a special School Board meeting on Tuesday, January 7, 2019, beginning at 5:30 pm in the Board Room at the Secondary School for the purpose of conducting the annual organizational meeting of the School Board. The oath and election of officers will be conducted by the Board Clerk.
