Student Achievement

1:1 Mobile Device Handbook for 2018-2019: The Board approved the handbook. There are no changes from the previous year handbook.

NRHEG Community Education Youth Development Plan: Community Education Director Macy Whiteside presented the Youth Development Plan that includes three goals including:

- Work collaboratively with community-based organizations and schools to foster productive relationships that benefit youth
- Provide programs that engage youth, support education, and foster independence and an interest in lifelong learning
- Create a Youth Advisory Council to engage youth to serve as advisors and provide input into Community Education programming

The Board approved the plan.

Student Handbooks 2018-2019: Dave Bunn and Doug Anderson presented changes to the student handbooks for the coming school year. The most notable changes are reflected with the adoption of MSBA's model student handbook that includes required and/or recommended policies and procedures in full and not just referencing policy numbers. However, no significant changes in student expectations, policies or procedures are being recommended. The Board approved the handbooks.

Facilities

Community Survey DRAFT: A draft of the Community Survey regarding facility planning was presented for Board input. The draft represented review and input from the Facility Planning Task Force, administration, ISG consultants and our survey firm School Perceptions. Following the Board's review, final revisions will be made before going to print. We hope to have the survey in homes by the second week of September with a closing date of October 1. A special Board meeting is planned for October 10 in conjunction with the sixth and final meeting of the Task Force. The purpose for the meeting will be to hear a report from School Perceptions on the survey results, and for the Task Force develop a recommendation to the Board for moving forward. The recommendation is planned to be presented to the Board at the October 15 School Board meeting.

Contract for Physical Therapy Services with Health Dimensions Rehabilitation, Inc. for 2018-2019 School Year: The Board renewed our agreement with HDR. The rate and all other terms is an increase of \$2 from last year. HDR will bill monthly for services at a rate of \$65.00 per hour plus mileage.

<u>Catastrophic Insurance for 2018-2019</u>: The Board renewed participation in making available coverage for students in grades 6-8 participating in co-curricular programs. The total cost for the coverage will be \$600. This is the same amount as the 2018-2019 school year.

<u>Bus Lease Agreement</u>: The Board approved a lease agreement for two 2019 International 77 passenger School Buses with payments of \$26,515 per year for four years.

Board Governance -- Policy

1st Reading of Policy #515 Protection and Privacy of Pupil Records including 515P-Procedure for Special Education Student Records: The Board approved the first reading of a revision to Policy #515 (Part XX) to include a procedure for Special Education Student Records. This is follow-up to the Board's action taken at the July School Board Meeting to adopt the School District General Records Retention Schedule published by the Minnesota Historical Society (MHS). The Board will consider the 2nd and final reading of the revised policy and procedure at the September 17 School Board meeting.

1st Reading of MSBA Recommended Revised Policies: The Board approved the first reading of the revised policies listed below as provided by the Minnesota School Board Association. The Board will consider the 2nd and final reading of the revised policies at the September 17 School Board meeting.

- a) Equal Educational Opportunity—102: Definition of "sexual orientation" in the Minnesota Human Rights Act includes "gender identity and expression." List of protected categories changed to match this definition.

- e) Public Participation in School Board Meetings/Complaints about Person at School Board Meetings and Data Privacy Considerations—206: "Public" no longer limited to citizens of the school district. The Board made significant revisions a year ago to this policy to allow for public comments at regularly scheduled Board meetings but had limited those who could speak to residents or citizens of the School District. MSBA is recommending a change from "citizens" to "persons" so those who speak are not limited to only residents of the School District.
- **d)** Equal Employment Opportunity—401: Definition of "sexual orientation" in the Minnesota Human Rights Act includes "gender identity and expression." List of protected categories changed to match this definition.
- e) Harassment and Violence—413: Definition of "sexual orientation" in the Minnesota Human Rights Act includes "gender identity and expression." List of protected categories changed to match this definition.

- t) Student Transportation Safety Policy—709: One exception eliminated from Paragraph V.E.
