2. Building Administrator Reports

- 3. *Board & Administrator for Board Members Monthly Publication – February 2017 Reflection* - I** have provided a brief reflection on a few of the articles from the February publication. I hope you have had an opportunity to read and reflect.

- Tour of Gratitude boosts teamwork, commitment to mission – The article shares a testimonial from a school board in Rockford, Washington, from its “Tour of Gratitude,” where the Board and Leadership Team spend a day-long work session taking a tour of the district as they reflected “on past accomplishments, as well as an opportunity to recharge batteries for the coming work.” The Board Chair commented “the day strengthened relationships on the board team and with the leadership team while informing the board’s work.”
- Tamp down on board conflict with these strategies – The article offers board members strategies when the board is having teamwork issues. Strategies included:
 - ✓ Understand conflict is natural
 - ✓ Do not avoid conflicts – resolve them
 - ✓ Achieve consensus by airing complaints and disagreements and by giving all views a fair hearing
 - ✓ Use more “carrot, less stick.”
- Does your superintendent know what the board wants? -- The article recommends the board working closely with the superintendent to “set common goals for the district so that the administrator has no doubt in her mind what the board wants to accomplish.” The article suggests the board reflect on questions to check the clarity of the direction the board gives the superintendent.
- Duties of the Board President – The article provides examples of typical duties for the board chair.

6. **Committee Meetings Planned** – The Policy Committee is scheduled to meet at 5:30 pm on March 20 prior to the start of the regular School Board meeting. The agenda includes review and discussion of two policies: Public Comments (206) and Consent Agenda (203.6). The Building and Grounds Committee meeting is scheduled to meet on Wednesday, March 29, beginning at 5:00 pm in the Board Room. The agenda will included a review of proposals received for the potential Ellendale Softball Field Complex parking and field access project.
7. **Paraprofessional Association Negotiations** – The first negotiations meeting with the Paraprofessional Association is planned for Tuesday, March 21, beginning at 5:30 pm in the Secondary School Media Center.

- 11. Board Work Session** – In addition to a potential work session on Communication & Marketing, other topics may include reviewing progress being made on the District's Strategic Plan, Board goals, and Superintendent goals. This would be a continuation of the Board's work on January 30.
