### **MINUTES**

1. Call to Order—Meeting called to order by Chair, Rick Schultz. The School Board of Ind. School District #2168 met in regular session on July 17, 2017 at 6:30PM.

### 3. Roll Call:

- **4. Approve Agenda**—Moved by JoAnn Maloney, seconded by Neil Schlaak to approve the agenda as presented. Motion Carried 5-0.
- 7. Approve Minutes of Regular Meeting June 19, 2017—Moved by Travis Routh, seconded by Karen Flatness to approve the minutes of the regular meeting of June 19, 2017 as presented. Motion carried 5-0.
  - Approve the Minutes of the School Board Work Session July 12, 2017—Moved by Travis Routh, seconded by Karen Flatness to approve the minutes of the School Board Work Session of July 12, 2017 as presented. Motion carried 5-0.
- 8. Consideration of bills \$1,079,817.45—Moved by Travis Routh, seconded by Karen Flatness to approve the bills in the amount of \$1,079,817.45 as presented. Motion carried 5-0.

#### 13. New Business

- a. Finance:

  - Lunch and Milk Prices for 2017-2018: Moved by Neil Schlaak, seconded by Karen Flatness to approve the breakfast and lunch prices for the 2017-2018 school year. Breakfast for Grades K-12 will be \$1.30; Lunch for Grades K-5 will be \$2.55; Lunch for Grades 6-12 will be \$2.70; Lunch for Adults will be at the Federal Government Rate rounded up to the nearest nickel. Milk will be \$0.40. Motion carried 6-0.
  - 3. **Minnesota School Board Association membership Renewal:** Moved by Karen Flatness, seconded by Neil Schlaak to approve membership to the Minnesota School Board Association. The Association dues are \$4,057.00 and the Policy Services Renewal is \$675.00 per year for a total of \$4,732.00. Motion carried 6-0.

The agreement is a two (2) year contract with a hourly wage increase of 2.75% at a rate of \$17.66 for the 2017-2018 fiscal year and hourly wage increase of 2.75% at a rate of \$18.15 for the 2018-2019 fiscal year. Motion carried 6-0.

- 6. Agreement with JWP for Staff Sharing of (COTA) Certified Occupation Therapist Assistant: Moved by Neil Schlaak, seconded by Dan Schmidt to approve the agreement with JWP for Instructional Staff Sharing of the COTA for the 2017-2018 school year as presented. Motion carried 6-0.

Hourly Rate of \$36.53, Maximum Hours is 16, Prep hours/1 per 6 hours direct student contact and Total Eligible Salary of \$669.72 as presented. Motion carried 6-0.
