We continue to live-stream the Board meeting via YouTube. Board members and essential staff will continue using *Google Meet* to access and participate in the meeting.

- 3. Recommendation to Extend Secondary School Distance Learning Model The Board will see in the Board Packet for Monday night a recommendation to extend the Secondary School *distance learning* period through Friday, December 4, with a tentative return date of Monday, December 7. This recommendation is made based on the following:
 - County case rates continue to trend upward
 - County positivity rates continue to trend upward
 - District continues to experience positive cases and quarantines with majority in Secondary School
 - Public health officials cautioning schools to prepare for potential increase in virus spread following Thanksgiving holiday
- 4. Facilities with Cases and Exposures This week, the Secondary School was included on the "Facilities with Cases & Exposures" list that you can find on the MDH's website (at the bottom of the page under "Facilities with Cases & Exposures"). School buildings with five or more confirmed COVID-19 cases are identified. School buildings' names will come off the identified list if they have no new confirmed cases after 28 days, which is two incubation cycles.

- 5. School Learning Model Look-up If you want look up a specific learning model for a school district or school, you can go to the MDE website at Enter the Safe Learning Model Look-Up system. Simply enter the school district you are seeking.
- 6. Building and Grounds Committee Meeting to Meet The next Building and Grounds Committee Meeting is tentatively planned for Tuesday, January 19, 2021, beginning at 5:30 pm prior to the start of the regular School Board meeting. Agenda items may include discussion about potential land sale, construction project follow-up, and examining the Board's goal of developing a long-term facility plan.
